Directions From I-85 and I-985

From Atlanta take I-85 North, bear left on I-985, get off at Exit 22, turn left onto Hwy 129 North which will turn into Hwy 129/E.E. Butler Parkway. Office is approximately 1.9 miles from I-985. When you get to the intersection of E. E. Butler and Jesse Jewell, go through that light and the next two light, turn right at the next street which is Brenau Ave and take an immediate left into our parking lot. We are the 2-story gray stucco building (200 E. E. Butler Parkway). If you go through the 4th light and go around the curve you have gone too far, that becomes Hwy. 129/Green Street.

From South I-85 take Exit 137, turn right onto Hwy 129 North. Office is approximately 16 miles. Hwy. 129 will become E. E. Butler Parkway as you get into town. At the intersection of E. E. Butler and Jesse Jewell, go through that light and the next 2 lights, turn right at the next street which is Brenau Ave and take an immediate left into our parking lot. We are the 2-story gray stucco building (200 E. E. Butler Parkway). If you go through the 4th light and go around the curve you have gone too far, that becomes Hwy. 129/Green Street.

From Habersham take Hwy. 365 South, take Exit 24, and turn right. That is Hwy. 369 which will become Jesse Jewell Parkway. Go past Northeast Georgia Medical Center to 2nd light which is the intersection of Jesse Jewell and E. E. Butler Parkway, turn right on E. E. Butler, go through the next 2 lights, turn right at the next street which is Brenau Ave and take an immediate left into our parking lot. We are the 2-story gray stucco building (200 E. E. Butler Parkway). If you go through the 4th light and go around the curve you have gone too far, that becomes Hwy. 129/Green Street.

Directions From 400

From 400, Exit 17, turn right, go to light at Hwy 369 which is also Brown's Bridge Road, and turn right. Continue into Gainesville. Hwy 369/Browns Bridge Road will become Jesse Jewell Parkway. Go to the intersection of Jesse Jewell and E. E. Butler, turn left onto E. E. Butler (make sure that you are on the right hand lane of the turn left lane, there are two left turn lanes) go through the next two lights turn right at the next street which is Brenau Ave and take an immediate left into our parking lot. We are the 2-story gray stucco building (200 E. E. Butler Parkway). If you go through the 4th light and go around the curve you have gone too far, that becomes Hwy. 129/Green Street.

From 400 take Hwy 53 (Dawsonville Hwy) go towards Gainesville, continue on Hwy. 53, when you get into Gainesville, Hwy. 53 will become John Morrow Parkway, continue until you get to the intersection of John Morrow Parkway and Jesse Jewell Parkway (make sure that you are in the left lane), turn left onto Jesse Jewell, continue on Jesse Jewell to the intersection of Jesse Jewell Parkway and E. E. Butler (make sure that you are on the right hand lane of the 2 left turn lane, there are two left turn lanes). Turn left and go through the next two lightes, turn right at the next street which is Brenau Ave. and take an immediate left into our parking lot. We are the 2-story gray stucco building (200 E. E. Butler Parkway). If you go through the 4th light and go around the curve you have gone too far, that becomes Hwy. 129/Green Street.
